WAIVER AND RELEASE OF LIABILITY:

The undersigned has applied for membership in, or has otherwise sought to participate in the activities of, the New York Ramblers Soccer Club, a not-for-profit organization formally incorporated under the laws of the State of New York as Ramblers Soccer NY, Inc. In consideration of the acceptance of the undersigned's application for membership in the New York Ramblers, or without actual membership being permitted to participate in soccer, and other sporting, activities and events sponsored or engaged in by the New York Ramblers, the undersigned has executed and delivered this Waiver and Release of Liability, which shall be deemed in full force and effect from and after the date hereof as to any and all such activities and events in which undersigned may participate.

The undersigned affirms that he or she is over the age of eighteen (18) years, acknowledges and fully understands that he or she will be engaging in activities that involve the risk of serious injury, including permanent disability and death and severe economic and social losses which could result not only from the undersigned's own actions, inactions or negligence, but also from the actions, inactions and negligence of others, the rules of play and conditions of any fields or premises or any of the equipment used by the Ramblers, and the undersigned further acknowledges that there may be other unknown or unforeseeable risks, and the undersigned hereby assumes all of the foregoing risks and accepts personal responsibility for any and all damages, including any such injuries, personal disability or death. The undersigned further releases, waives and covenants on behalf of himself or herself and his or her heirs, distributees, executors, administrators, legal representatives, successors and assigns not to institute any legal proceedings, claims, or causes of action, against the New York Ramblers, or its respective members, officers, directors or agents, or against any of its sponsors and, if applicable, the owners and leasers of facilities or permits used to conduct any and all events in which the Ramblers may participate, for any and all liability to the undersigned, his or her heirs or distributees, executors, administrators, legal representatives, successors and assigns for any and all claims, demands, losses or damages on account of injury, including disability and death, or damage to property, caused or alleged to be caused in whole or in part by the negligence of the New York Ramblers, its respective members, officers, directors or agents or other abovementioned persons or corporations or otherwise.

In the event of any dispute, conflict action or interpretation of this Waiver and Release, the laws of the State of New York shall govern.

THE UNDERSIGNED HAS READ AND AGREES TO ALL OF THE TERMS AND PROVISIONS OF THE ABOVE WAIVER AND RELEASE, UNDERSTANDS THAT HE OR SHE WILL GIVE UP SIGNIFICANT RIGHTS BY SIGNING IT, AND HEREBY SIGNS IT VOLUNTARILY.
